
## The Bay of Fundy Walk on the Bottom of the Sea

## New Brunswick, Canada

Saint John • Hopewell Rocks
Bangor • Bar Harbor • Acadia National Park
luly 12-18. 2025 Sat-Fri

DAY 1: Board a deluxe motorcoach and head off for a 7-day adventure. Overnight in **BANGOR**, **MAINE** with welcome dinner.

DAY 5: Bid adieu to New Brunswick, cross the border and head for **BAR HARBOR, MAINE.** 2 nights at the **ATLANTIC OCEANSIDE HOTEL.**Situated on 12 acres of oceanfront property offering waterfront access to gorgeous Frenchman Bay. Dinner tonight in our hotel.
