Final Payment: Feb 24, 2025. **Final Payment Incentive:** Pay your Final Payment by Check and Receive \$100 per cabin onboard credit!

Cancellation Penalty: If cancelled after deposit and before Feb 24, 2025 fee of \$150.pp; Feb 25-Mar 17, 2025 fee of 50% of total fare; Mar 18-Apr 10, 2025 fee of 75% of total fare; No refunds after Apr 10, 2025. Air penalties are not included in above and may be additional.
